The fall 2023 election period spanned from the 1st day of September to the 29th day of September in the year 2023.

The purpose of this document is to relay the methodology, candidates, results, notable events, and any associated details from the said elections, ensuring that all stakeholders have a comprehensive understanding of the proceedings.

This report aims to uphold the transparency and credibility of the VUSAC election process, recognizing the importance of student representation and leadership within the Victoria University community.

Executive Summary

The VUSAC Fall 2023 Elections, which spanned from the 1st to the 29th of September, 2023, aimed at filling vacancies for Councillors, International Councillor, and a seat on the VCC. Out of the available positions, eight were for Councillors - consisting of specific reservations based on academic years, one for International Councillor, and one for the VCC, considering nine seats were filled earlier in the Spring elections.

The nominations period initiated on the 1st of September, 2023 and encountered a brief technical hitch concerning access to the nomination forms, which was swiftly resolved. A total of 15 valid nominations were received, encompassing positions for Councillors and the International Councillor, while none were received for the VCC. Two candidates subsequently withdrew their nominations, and penalties were administered for certain rule violations.

To aid in understanding the electoral process and to offer clarifications, two information sessions were organised, both of which saw a commendable turnout. An All Candidates Meeting was held on the 14th of September, 2023, facilitated by an ACRO in my absence.

The campaign period, which ran from the 14th to the 25th of September, 2023, presented various challenges, prompting the issuance of penalties for specific campaign rule breaches. An educational session intended to elucidate the ranked-voting system was conducted on the 19th of September, albeit with limited participation. During the campaign, candidates were required to submit their profiles and budgets, leading to a Town Hall where they presented their platforms to the VCU.

Voting took place from the 21st to the 25th of September, 2023, with a participation of 11.46% from the VCU. The silent period following the voting witnessed a significant rule breach by a candidate, details of which are elaborated upon in subsequent sections. Notwithstanding, the results were published on the 28th of September, with due adjustments made to adhere to the VUSAC's reservation guidelines.

The election's culmination was marked by a ratification meeting on the 29th of September, 2023, where the newly elected candidates were proposed for formal recognition. This comprehensive report on the elections was officially released on the 14th of November, 2023, albeit delayed due to personal contingencies.

Throughout the election period, earnest efforts were made to maintain the integrity and transparency of the process. Acknowledging the technical challenges and certain oversights, I extend my apologies to the VCU and assure of continued diligence in upcoming election cycles.

Election Process

Nominations Period

The Nominations Period for the fall 2023 elections began at the stroke of midnight on the 1st of September, 2023, and concluded at noon on the 14th of September, 2023.

Concurrent with the opening of the nominations, the official Nominations Package was made available on the VUSAC website. Additionally, Tanya Kor, the Communications Coordinator, executed a well-timed communication strategy, issuing announcements about the elections both in advance and on the first day of the nomination period to ensure maximum awareness and participation.

The period witnessed an active participation, with a total of 15 nominations being received. These nominations were for two distinct positions within the council: Councillors and International Councillor. Despite the active participation, there were no nominees for the open seat on the VCC. After consultation with Shane Joy, Chair of the EAC, it was decided not to extend the nomination period for this specific seat.

There were initial technical difficulties encountered with the online nomination portal, specifically with its compatibility with the Safari web browser. This issue was promptly identified and rectified by Tanya Kor, the Communications Coordinator.

Additionally, access issues to the alternate nomination forms via Google Forms were reported. This problem, initially overlooked by me as a potential user error, was later identified as a restriction setting issue that inadvertently limited access to VUSAC and its trusted organisations. Upon realisation, this issue was immediately corrected. As the CRO, I extend my apologies for these oversights and affirm my commitment to preventing such occurrences in future elections.

During this period, 3 candidates - Erin Timur, and Andrew Fan (with the third individual's name redacted at their request) - were penalised for exceeding the permissible number of nominators. This decision was based on the evidence provided by the nominators' lists.

Two informational and Q&A sessions were conducted to assist and guide potential candidates and interested parties. The first session was held on the 12th of September, 2023, from 5:30 pm to 6:30 pm, and the second on 13th of September, 2023, from 18:30:00 hrs (06:30:00 pm) to 19:30:00 hrs (07:30:00 pm). Both sessions recorded impressive attendance, surpassing the previous year's turnout, as noted by Shane Joy, the President of the Council.

Following the closure of the nomination period, I, as the CRO, communicated via email to all candidates who met the nomination requirements, confirming their candidacy for the respective positions in the VUSAC elections.

All Candidates Meeting

The All Candidates Meeting for the elections was held on 14th of September, 2023. Scheduled from 18:00:00 hrs (06:00:00 pm) to 20:00:00 hrs (08:00:00 pm), this critical meeting took place

at the VUSAC Office, serving as a foundational event for all candidates participating in the election.

In my absence due to an academic commitment, the meeting was chaired by one of the ACROs, Shane Joy. His leadership ensured the meeting progressed seamlessly and all pertinent information was effectively communicated to the candidates.

The following candidates were unable to attend the meeting:

- 1. Albert Deok-Hyun Ahn
- 2. Logan William Kliewer
- 3. Amoly Agarwal
- 4. Aiko Hashimoto Reis

In compliance with Chapter 9, Article 16, Section 1c) and 1d) of the ERC, some absent candidates had designated proxies to represent them at the meeting. For those who were unable to assign proxies, the VUSAC took the initiative to assign proxies on their behalf, ensuring that all candidates were represented and could receive the necessary information.

The meeting was conducted with remarkable smoothness and efficiency, a testament to the meticulous planning and organisation by the VUSAC.

Key aspects covered in the meeting included detailed campaigning guidelines and further procedural steps in the election process. This information is crucial for maintaining a fair and transparent electoral process.

Candidates were also given ample opportunity to raise questions and seek clarifications. This interactive segment ensured that all candidates had a clear understanding of the rules, expectations, and their responsibilities during the remainder of the elections period.

The All Candidates Meeting marked an essential milestone in the VUSAC electoral process, setting the stage for a well-informed and structured campaign period.

The success of the meeting, marked by effective communication and active participation, highlighted the commitment of the VUSAC and the candidates to a fair and democratic election process.

Campaign Period

The campaign period for the elections, a pivotal phase in the electoral process, spanned from 14th of September at 20:00:00 hrs (08:00:00 pm) to 25th of September at 23:59:59 hrs (11:59:59 pm). This period was characterised by a mix of adherence to regulations, technological engagements, educational efforts, candidate withdrawals, and the need for disciplinary actions.

As the candidates launched their campaigns, they displayed posters in alignment with the guidelines set forth in Chapter 9 of the ERC. However, an exception occurred with candidate Richelle Furtado. I received an email from the latter seeking approval for an incomplete poster, intended to be finalised with a QR code. After rejecting the request and advising them to submit the completed poster, no further correspondence was received.

During this period, the VUSAC website's election forum was activated, offering a digital space for interaction between the Victoria College Union (VCU) and the candidates. Despite its availability, the forum witnessed subdued participation. The highest level of activity was recorded on September 18th, with 208 views, 27 unique visitors, and only 4 posts, indicating a relatively low engagement level.

A significant event was the Voter Education Session held on September 19th. Aimed at explaining the newly introduced ranked voting system, the session unfortunately attracted only 2 of the 3,971 eligible electors, translating to a meagre 0.05% turnout. The session faced challenges, partly due to my initial lack of familiarity with the ranked voting process, leading to some mistakes in its explanation. I extend my apologies for these shortcomings and am committed to enhancing my understanding for improved delivery in future sessions.

The campaign also saw the withdrawal of two candidates: Liren Abeyratne on the 19th of September, 2023 and Maria Francesca Policarpio on the 20th of September, 2023. These withdrawals altered the election dynamics mid-campaign.

A crucial deadline during this phase was the submission of candidate profiles and budgets by the 20th of September, 2023. All profiles were submitted on time, but only 10 candidates met the extended budget submission deadline. I acknowledge a communication gap regarding the need to submit a nil budget for candidates with no expenditures, for which I take full responsibility.

A significant incident occurred on the 24th of September, 2023 when a particular candidate reported their campaign posters had been tampered with. Despite efforts to investigate, including a physical inspection of the poster sites and an email appeal to candidates and resident and commuter dons, the investigation faced challenges due to limited resources and access. As compensation, I advised the candidate that they could print additional posters.

The campaign period also necessitated several penalty issues. Warnings were issued to several candidates for various infractions, including improper poster placements and inactivity on the election forum. Additionally, Candidate X received a strike for inappropriate ballot ranking suggestions, and another candidate, hereafter referred to as Y, was disqualified for slanderous comments against another candidate (Refer to <u>The Case of Candidate Y versus the Chief Returning Officer (CRO)</u>).

In summary, the campaign period was a dynamic and multifaceted phase of the elections, marked by a commitment to uphold the electoral code, address technological and educational challenges, and enforce disciplinary measures to ensure a fair and transparent election process.

Town Hall

On the 20th of September, 2023, VUSAC held a Town Hall from 17:30:00 hrs (05:30:00 pm) to 19:30:00 hrs (07:30:00 pm), providing a vital platform for candidates to present their ideas and interact with the electorate.

The event saw adjustments to accommodate academic commitments of several candidates. Aiko Hashimoto Reis departed early, while Erin Timur, unable to attend, sent a video of their

speech, which I presented during the First Year Councillor segment. Andrew Fan arrived late due to similar commitments. Richelle Furtado, also absent for academic reasons, forwarded a copy of their speech, which Shane Joy, the ACRO, read on their behalf. Apart from these candidates, the rest were present, ensuring robust participation.

The Town Hall included an anonymous question submission form, which received a total of 9 questions, predominantly from council members. This allowed for a diverse range of inquiries, reflecting the concerns and curiosities of both the council and the student body.

Following the presentations by candidates for a particular position, a live question and answer session was conducted, offering a direct and interactive platform for candidates and the VCU. This format facilitated a dynamic exchange between the candidates and the audience, contributing to a more engaging and informative session.

The entire Town Hall was recorded, ensuring that those who could not attend could still access the discussions and presentations. This was in line with our commitment to transparency and inclusivity.

In adherence to Chapter 9, Article 16, Section 2 of the ERC, all guidelines were meticulously followed. This ensured a structured and fair environment for all candidates to present their platforms and engage with electors.

Despite these efforts, the turnout at the Town Hall was moderate, with approximately 40 members of the VCU, including VUSAC members and candidates, in attendance. While this number was not as high as hoped, it still represented a significant portion of the engaged electorate.

Overall, the Town Hall ran smoothly, marked by effective coordination, respectful discourse, and adherence to the established electoral guidelines. It served as an essential component of the democratic process, offering a comprehensive view of the candidates and their visions for the VUSAC.

Ballots and the Voting Period

The voting period for the elections spanned from midnight on the 21st of September, 2023 to 23:59:59 hrs (11:59:59 pm) on the 25th of September, 2023 a critical phase where the electorate voiced their choices.

Significantly, the campaign period overlapped with the voting period, allowing candidates to continue their campaigning efforts throughout the voting duration. This provided a unique opportunity for candidates to engage with electors up until the last moment, potentially influencing final voting decisions.

For the execution of the voting process, VUSAC collaborated with Simply Voting, marking a shift from previous elections where the voting system was managed by the UTSU's Simply Voting system. This change granted me, as the CRO, full control over the voting system, enhancing the efficiency and responsiveness of the electoral process.

Two voting options were available to the electors: online voting, which could be accessed anywhere with internet connectivity, and physical voting kiosks situated within the VUSAC office

during office hours. This dual approach aimed to maximise accessibility and convenience for all electors.

To accommodate the diverse linguistic background of the electorate, technical information on the ballot was provided in 18 different languages, reflecting VUSAC's commitment to inclusivity.

A notable feature of this election was the flexibility allowed in vote changes. Electors had the liberty to change their votes multiple times during the voting period, with only the final submission being recorded. This feature was a departure from previous elections and was designed to provide electors with greater flexibility in their decision-making process.

The election employed a ranked voting system. However, due to compatibility issues with Simply Voting's Election Manager and the counting method prescribed in Chapter 11 of the electoral code, a slightly modified counting method was used. After thorough discussions with Simply Voting's support team and testing various counting methods, it was assured that this adaptation did not impact the election results.

The turnout, however, was notably low. Of the 3,971 eligible electors, only 455 cast their votes, resulting in an 11.5% turnout. To encourage higher participation, I initiated a series of reminder email blasts. Initially, these reminders were sent to all electors, but later we targeted only those who had not yet voted.

During the voting period, an average of 91 electors voted per day. The data showed a surge in activity at the commencement of the voting period, with the highest number of votes, 169, recorded on the first day, particularly in the first 1.5 hours. Thereafter, there was a noticeable decline in daily votes.

Despite the low turnout, the voting process itself was remarkably smooth. There were no reported technical issues with the Simply Voting system, which marked a significant improvement from previous elections.

In summary, the voting period of the Fall 2023 VUSAC elections was characterised by an overlap with the campaign period, a flexible voting system, linguistic inclusivity, a modified yet effective counting method, a concerted effort to boost turnout, and a smooth technical execution, culminating in a critical phase of the democratic process.

Silent Period

The Silent Period for the elections, a crucial time for reflection and decision-making, commenced at midnight on the 26th of September, 2023 and concluded on the 27th of September, 2023 at 23:59:59 hrs (11:59:59 pm).

As soon as the election results became available on the Simply Voting Election Manager, I engaged in a meeting with Shane Joy, the chair of the EAC, to review and adjust the results, ensuring they met VUSAC's councillor reserve requirements. Following this, I updated the individual unconfirmed result pages for all candidates and notified them via email to review their respective results.

A significant development during this period involved the disqualification of candidate Y due to slander, which was under appeal. This situation created uncertainty regarding the results for two

councillor positions: Y's and the next candidate in line for election if Y's appeal was rejected. Initially, their results were displayed as 'Pending Review.' However, after further discussion with Shane Joy, we decided to adjust the display to 'Elected (Pending Review)' for Y and 'Not Elected (Pending Review)' for the other candidate. This decision was informed by the understanding that candidates were aware these results were provisional and subject to change post-Silent Period.

Complicating matters, Y violated the rules of the Silent Period by discussing their disqualification penalty with a VUSAC member and another candidate. We had concrete evidence of this breach, leading to the issuance of another disqualification penalty to Y. This second disqualification was also appealed and under review by the EAC.

While the EAC rejected Y's appeal against the first disqualification (slander), the second appeal (Silent Period violation) was not resolved promptly. Consequently, I decided to withdraw the second penalty. This decision, and the reasoning behind it, will be elaborated in the case analysis section. Both the penalty and the appeal were subsequently omitted from the penalties and appeals page on the VUSAC website.

After final decisions on both appeals were made, I updated the individual unconfirmed results for Y and the other candidate once more and notified them via email about the updates.

The Silent Period, typically a time of calm before the finalisation of results, was marked by significant challenges due to the issues surrounding Y. While most candidates adhered to the rules of the Silent Period, Y's actions led to complications that disrupted the otherwise smooth flow of this crucial phase in the electoral process.

Publishing of Results and the Election Ratification Meeting

On the 28th of September, 2023, at the stroke of midnight, I transmitted the final confirmed results of the VUSAC elections to Tanya Kor, the Communications Coordinator, marking the culmination of a meticulous electoral process. Adhering to the guidelines outlined in Chapter 13, Article 23, Section 2 of the ERC, this timing was critical to avoid breaching the Silent Period rules. The first disclosure of these results occurred on VUSAC's Instagram page, followed by a hard copy display outside the VUSAC office on the same day. Simultaneously, Tanya and I began the task of updating the VUSAC website with the final results, a process that required meticulous updating of various databases, taking a few days to complete.

With the results now public, I proceeded to prepare the Certificates of Election, ensuring timely access for candidates via their individual results pages. This part of the process encountered no delays and was executed as planned.

In preparation for the election ratification meeting scheduled for the 29th of September, 2023, I prepared the official Certificate of Results. This document was to be presented to the VUSAC and accepted by the President of the Council, Shane Joy, as an official acknowledgment and an invitation for the council to consider ratifying the newly elected candidates. This preparation phase proceeded smoothly, with all necessary documents ready for the upcoming meeting.

The election ratification meeting was a significant event, marking the final stage in the electoral process. Unaware that attendance was optional for unelected candidates, I informed all

candidates to be present. This oversight highlighted a need for me to deepen my understanding of the ERC for future elections.

During the meeting, President Shane Joy, initiated a motion to ratify the newly elected council members which was seconded by VPI Lara Athena Reyes. Following this proposal, I presented the election results and the Certificate of Results to the council. President Joy accepted these on behalf of the council, and I invited them to proceed with the ratification.

A notable moment arose when candidate Y, one of the candidates, expressed concerns about the election process and its impact on their health. They also informed the council and the VCU of a complaint filed with the Victoria College Office of the Dean of Students, a development of which I was previously unaware. Following Y's statement, there were no further comments, and the council moved to ratify the elected candidates with a majority vote. However, I intend to account for Y's distress and I will ensure that electoral processes are followed more accurately and a variety of support systems are available during future elections.

The publishing of the election results and the subsequent ratification meeting encapsulated the final steps of the VUSAC elections. From the careful release of results to the formal ratification of elected members, each step was carried out with attention to detail and adherence to electoral guidelines. The meeting not only served as a formal conclusion to the electoral process but also as a forum for reflection and feedback, pivotal for the continuous improvement of future VUSAC elections.

The Case of Candidate Y versus the Chief Returning Officer (CRO)

This report examines a complex case involving a candidate in the Fall 2023 VUSAC elections. The candidate in question, referred to herein as "Candidate Y," was involved in a series of events that led to accusations, investigations, penalties, and appeals, ultimately influencing the election's outcome. The narrative details the sequence of these events, the procedural actions taken, and the resolutions reached.

On 25th of September, 2023, allegations emerged against Candidate Y regarding slanderous comments made against another candidate via social media. This information, reported by a member of the VCU to a VUSAC member, triggered a preliminary investigation. During this phase, there was a procedural misstep as I, the CRO, consulted with the VUSAC member, deviating from standard protocols.

Further evidence was sought from the VCU member and the victim candidate, who wished to remain anonymous. In the process, assurances were given to maintain confidentiality, with an understanding that VUSAC could not control disclosures by non-members.

After careful consideration, a disqualification notice was issued to Candidate Y for violating Chapter 9, Article 19, Section 1 of the ERC. During this process, I engaged in a conversation with Candidate Y, inadvertently breaching procedural guidelines. This discussion led Candidate Y to highlight perceived procedural flaws and request a reconsideration of the decision.

Simultaneously, another candidate, found in violation of Chapter 11, Article 21, Section 5 of the <u>ERC</u>, was issued a strike. Meanwhile, Candidate Y was found to have communicated about their disqualification with other VUSAC and VCU members, infringing upon the silent period rules as outlined in Chapter 13, Article 23, Section 2 of the <u>ERC</u>, resulting in an additional disqualification penalty.

Candidate Y lodged appeals against both penalties. The first appeal, related to the slanderous comments, was dismissed by the EAC through a majority vote. The second appeal, pertaining to the silent period violation, faced a deadlock within the EAC. In consideration of fairness, the second penalty was subsequently withdrawn, despite the evidence supporting it.

These events led to a proposal by the EAC Chair, Shane Joy, and myself, for a review of the EAC's structure and procedures to enhance the committee's effectiveness.

The decision to uphold Candidate Y's disqualification for the slanderous comments was cemented by the EAC's rejection of the first appeal. This outcome allowed for the election of the next eligible candidate in line. During the election ratification meeting on September 29, 2023, concerns were raised by Candidate Y about the electoral process's impact on their well-being. These concerns were escalated to the Office of the Dean of Students and subsequently addressed by the EAC Chair.

This case, while challenging, underscores the VUSAC's dedication to maintaining due process, transparency, and fairness in its electoral framework. It also highlights the need for continual

procedural refinement and improvement, ensuring that future elections are conducted with the utmost integrity and respect for all participants.
Breaches of the ERC (Revised July 2023)
Chapter 4, Article 4, Section 1
During the elections, a notable breach occurred with respect to Chapter 4, Article 4, Section 1 of the <u>ERC</u> . This section outlines the requirement for the Chief Returning Officer (CRO), in

collaboration with the Chair, to ensure that at least one regular VUSAC meeting is held during the nomination period. The intent behind this stipulation is to maintain the continuity of VUSAC's operations during election periods.

However, during the Fall 2023 elections, this requirement was inadvertently breached. The pre-set schedule of VUSAC meetings, which was established well in advance, did not align with the nominations period. Adjusting this fixed schedule proved challenging, leading to the decision not to hold a meeting within the nomination period.

Several factors contributed to this breach:

- 1. Scheduling Conflicts: The established VUSAC meeting dates conflicted with the nomination period, and logistical challenges prevented their rescheduling.
- 2. Orientation Activities Overlap: The overlap of Victoria College's Incoming Student Orientation with the nomination period further complicated the scheduling. Many VUSAC members were actively involved in these orientation activities, making it difficult to organise a meeting during this time.
- 3. Historical Context: Historically, the requirement for a meeting during the nomination period was designed to ensure uninterrupted council operations during election times. However, VUSAC's practice of regular bi-weekly meetings, irrespective of election cycles, already fulfils this objective.

Despite the breach, VUSAC convened for its scheduled fall 2023 budget ratification meeting immediately following the conclusion of the nomination period. This meeting underscored the council's commitment to maintaining regular operations and decision-making processes, even during election cycles.

Given the practical challenges and the existing practice of regular council meetings, it is proposed that this specific requirement in the <u>ERC</u> be reconsidered. Removing the mandate for a meeting specifically during the nomination period could align the <u>ERC</u> with the operational realities of VUSAC while ensuring that council activities continue uninterrupted.

The breach of Chapter 4, Article 4, Section 1 of the <u>ERC</u> during the Fall 2023 VUSAC elections was a result of scheduling conflicts and was not intentional. It highlights the need for a re-evaluation of certain <u>ERC</u> stipulations to better align them with the practical and logistical realities of council operations. The proposed amendment aims to provide flexibility while ensuring the continuity and effectiveness of VUSAC's governance structure.

Chapter 11, Article 21, Section 3

During the elections, a notable breach occurred concerning the counting process stipulated in the <u>ERC</u>, specifically Chapter 11, Article 21, Section 3. This section mandates the use of IRV to determine election results, outlining a detailed procedure for ranking candidates and the conditions for declaring a position vacant.

The <u>ERC</u> guidelines for IRV include a sequential elimination of candidates with the fewest first-preference votes, reallocating these votes to next preferences until a candidate achieves more than 50% of the total votes, or 'Declare Vacant' reaches the same threshold. This method is iterative and responsive to each round of vote redistribution.

In contrast, the Simply Voting Election Manager utilised a different method - the Enforced "50% + 1" quota. This system calculates a fixed threshold for winning based on the number of valid votes cast, adjusted for any fractional part. Unlike the ERC-specified IRV method, this approach maintains a constant quota and does not adapt based on vote redistribution in successive rounds.

While this deviation from the <u>ERC</u> guidelines represents a technical breach, it is crucial to underscore that the integrity and fairness of the election were maintained. The Simply Voting system, despite its different counting method, ensured a transparent and objective determination of election outcomes. The deviation did not favour and / or disadvantage any candidate unduly.

The discrepancy was a result of technological limitations rather than any intent to deviate from established protocols. Efforts are being made to address this issue, with a commitment to ensuring closer alignment with the <u>ERC</u> in future elections and maintaining the highest standards of electoral integrity.

Chapter 12. Article 22. Section 7

Another breach occurred in relation to Chapter 12, Article 22, Section 7 of the <u>ERC</u>. This section dictates the procedural requirements for handling appeals during the Silent Period, specifically the conduct of virtual meetings and report preparations by the EAC.

The <u>ERC</u> mandates that upon receipt of an appeal, the EAC Chair is responsible for organising a virtual meeting involving the appellant, the CRO, and the EAC members. This meeting must occur within the 48-hour Silent Period, allowing for the presentation of cases by the appellant and the CRO. The proceedings are required to be recorded and stored, with a subsequent report of the outcome prepared and published within a week.


The breach was not a result of intentional oversight or disregard for the ERC. This process was not followed due to scheduling conflicts arising from the academic commitments of the EAC members, who are primarily students. The demanding nature of these commitments made it challenging to coordinate a meeting that was mutually convenient for all involved parties. As a result, the EAC Chair opted for an alternative approach using email voting to resolve appeals. Additionally, the preparation of a formal report post-proceedings became infeasible under these constraints.

Despite the breach, the EAC remained committed to a fair and just review of all appeals. Decisions were made with careful consideration of each case's merits, ensuring that the spirit of the ERC was upheld.

While the stipulated procedures for handling appeals were not followed in their entirety, alternative measures were put in place to ensure the appeals were handled fairly and efficiently. Going forward, a reevaluation of the ERC procedures is be necessary to better align with the practical realities of student-led election committees.









Voter Turnout











As the CRO for these elections, I extend my profound gratitude to the entire VUSAC, whose dedication and commitment were instrumental in the success of these elections.

Special thanks are due to the working group that meticulously audited and proposed necessary changes to the <u>ERC</u>. Their insightful contributions have significantly improved our electoral processes.

I would also like to express my deepest appreciation to Tanya Kor, the Communications Coordinator. Their co-development of the election portal has not only streamlined our processes but also marked a revolutionary transformation in VUSAC's history. This advancement has set a precedent for future elections, integrating technology and efficiency in our democratic processes.

My gratitude extends to Shane Joy, the ACRO, Chair of the EAC, and President of VUSAC, and Lara Athena Reyes, the ACRO and VPI of the VUSAC. Their unwavering support and guidance have been a cornerstone of the electoral process, ensuring its integrity and fairness.

Moreover, I acknowledge several mistakes and breaches that occurred during the election process. These include technical challenges during the nominations period, the modified counting method used by the Simply Voting Election Manager diverging from Chapter 11, Article 21, Section 3 of the ERC, and the breach of Chapter 12, Article 22, Section 7 of the ERC due to scheduling conflicts faced by the EAC. Additionally, there were issues in the campaign period, including communication gaps regarding candidate budget submissions and challenges in effectively investigating campaign poster tampering.

I extend my sincerest apologies to the candidates, VCU, and the entire VUSAC for these oversights and breaches. The responsibility for ensuring a smooth, transparent, and fair election process rests upon my office, and I regret any inconvenience or concern these issues may have caused. I am particularly remorseful for the complications arising from the modified vote counting method and the procedural deviations in handling appeals, recognizing that these aspects are fundamental to the integrity of the electoral process.

I am committed to learning from these experiences and taking proactive steps to prevent such mistakes in future elections. My office and the VUSAC will engage in a thorough review of the processes and systems used in this election, taking into account the unique challenges and constraints we faced.

Recommendations for Future Elections

- 1. **Review and Update of** ERC: Given the technological and logistical challenges encountered, a comprehensive review of the ERC is recommended. This review should consider the feasibility of current guidelines in light of available technology and the practical constraints of student-run election committees.
- 2. **Enhanced Communication Strategies:** Improving communication around key aspects of the election process, especially regarding candidate responsibilities like budget submissions, is crucial. Clear, frequent, and multi-channel communications should be

- established for future elections, especially effective communication strategies to engage the electorate, including more interactive and comprehensive voter education sessions.
- 3. **Technological Upgrades and Training:** Investing in and training for more robust election management software that aligns with <u>ERC</u> guidelines will be pivotal. Additionally, CRO and EAC members should receive adequate training on these systems to ensure smooth operation.
- 4. **Streamlining the Appeal Process:** Considering the challenges faced by the EAC, a more flexible approach to handling appeals should be explored. This may include alternative methods such as email voting or extending the timeline for scheduling virtual meetings.
- 5. Enhanced Resources for Investigation and Monitoring: Allocating resources for better monitoring of campaign activities and investigation of any misconduct is necessary. This may involve accessing security footage and coordinating with campus authorities to ensure fair play.
- 6. **Strengthened Oversight Mechanisms:** Implement stronger oversight mechanisms to ensure all election processes are conducted within the ERC guidelines.

In summary, the elections were a learning experience, marked by both successes and shortcomings. The dedication of the VUSAC, especially those in key roles, was paramount to the election's overall success. The lessons learned from this election cycle are invaluable and will guide the refinement of future election processes. The mistakes and breaches acknowledged herein have provided invaluable insights into areas that require improvement. By implementing the recommended changes and maintaining a commitment to continuous learning and adaptation, we can strive to uphold the highest standards of fairness and integrity in future elections. My office remains dedicated to serving the VCU with diligence and transparency, always striving for excellence in the democratic process.
