Spandan: I know it's a bad precedent to set, but doing this way, isn't it just creating a loophole that is also creating a bad precedent.

Vibhuti: It is a loophole, but a necessary one because it gives us more control over equitable aspects, if clubs keep overspending and coming into our contingency fund and we won't accept it. That's the logic behind it, not enabling people to overspend but a way for VUSAC to reimburse in a more mindful way.

Spandan: how is that any different from doing it directly?

Cam: I think the difference is that this method says that VUSAC has taken notice of the overspending, whereas if we went through the budget line would look like VUSAC will let it slide, we are aware it is against our policies.

Alexa: There is a difference since VUSAC didn't approve it in the budget, it's now something we have to add in because of the overspending.

DISCUSSION ITEMS:

- Equitable Hiring Policy (10 minutes) [Appendix A]

Katie: This is something Alexa and I started over the summer, looking at formalizing the process of hiring, this will hopefully provide a conceptualized place for all these policies to live, essentially just putting stuff we already do into a formal document, I hope you had a chance to look through it. It outlines how long hiring positions should be long for, who is required to sit in the hiring committees, etc. are there any questions?

Tran: Can we add to Highball Hiring Committee that we want to add a past member of Highball Committee?

Alexa: We're doing it as the policy is right now, since we don't know if those amendments are going to pass, then we can motion to amend based on this.

Jenny: This is really great, I have a question – I don't understand why the past member of the Bob technical team is there since that's not what happened for the hiring process.

Katie: That was passed last April. That's supposed to be what happens.

Fatima: Under Cats-Eye co-manager

Cam: PhysPlant services, they maintain physical services around Vic, I don't know why it was written into the Cats-Eye hiring policy but that is the policy, just so that they have some input, also staff input from the Campus Life Coordinator and from Food.

Michael: Food and Services also isn't on here.

Katie: Thank you!

Michelle: For chapter 3, it talks about hiring Ex-Officio members, then it talks about assessor members under that...

Katie: When we figure out the definitions, we will definitely amend that.

Alexa: Thank you Katie for this beautiful document!!

- International Councillor (10 minutes) [Appendix D]

Vibhuti: We've chatted about this a few times, this is a position that I really want to see on VUSAC, it is an important and needed position, a lot of our students in the past and majority of students are domestic students, and it's hard to get involved in student politics as a whole just because of the barriers it places if you are an international student. I believe this position will really help push VUSAC to a place where we can engage with International students in a meaningful way. This position would be a mixture between a co-chair position and a councilor, but in terms of VUSAC lingo would be a councilor. My first amendment is to add the, my second one would be their roles, I took some of their roles also from Equity and Sustainability advocation; subsection B is about the educational aspect, from Equity's portfolio because I think a large part of this portfolio should be about educational campaigns for international students to navigate a better university experience. They must pay international fees for the duration of their term, and will be elected in the fall with all the other councilors and have a separate Town Hall section and separate campaigns since it is very different. Amendment 3 is about that, I haven't indicated whether they could be a first year or upper year, but I think it should be open to all students since I think it would be a great way to get your foo din the door in student politics. Will be assigned under the VP-external portfolio, they usually get 2 councilors so they would then have 3. They have a collaborative role with the VPE. A lot of their tasks/programming, one would be geared towards international students and collaborating with international student organizations to widen VUSAC's reach and make more niche events for these students. That's my vision, if anyone has any questions or concerns or any amendments please let me know.

Disha: I think it's a very cool idea, I'm very happy to be moving forward, my question – the person in this position would have to pay international fees, but there are a lot of students who were born here so they're Canadians but they've been living out of Canada for 10 years, but they still fee domestic fees, so what about them?

Vibhuti: I think students paying international fees have a certain experience, and they understand the financial burden which is important to consider; domestic students don't have to navigate that, in terms of that that's why I positioned it in that way.

Fatima: A question linking to what Disha said, how can we ensure that they meet all the requirements when applying and they know what the requirements are, and do you think that students who have been living somewhere else for 10+ years but are born in Canada but moved somewhere else, do you think they would feel segregated because of that one point in the position? Vibhuti: I want to clarify in terms of the requirements, the fees make them a viable candidate, and if they are a Board or Regents member they have to be a Canadian citizen, that information is very thoroughly widespread, and to your second point, this is to help students who aren't well represented and to make sure we get that voice and a student who is hopefully excited for

advocating for these things and has the burden of the fees well best put on programming for all international students, that's the division there.

Jay: Is the only portfolio they will be assigned to the VPE's?

Vibhuti: Only the VPE portfolio because their role differs from other councilors in that they won't be hopping around the commissions and will be focused on international student advocacy.

Jay: I think the language is not that vague but you may read that as they could be assigned to more, maybe we should put an 'only' there to clarify. But then that might feel too constricting, so I'm not sure.

Vibhuti: I do like your insight on this, on those terms putting an only might be constricting, since if a student really wants to be involved with other portfolios they should be able to.

Jay: In the other subsection concerning general councilors, is there a point that states that general councilors sit on multiple portfolios? The contrast between the two subsections would make it more clear if that was the case.

Vibhuti: The other subsection will work under the assigned portfolios under the VPE.

Nerjia: with the elections, you have the first year and second year councilors they are running for the same position, but since this is a hybrid, how would that work in the elections? Would there be one reserved spot?

Vibhuti: I'm seeing this as a 9th councilor position; it would be first year, then upper year, then the international councilor.

Nerjia: If someone is running for the international councilor they can't be running for another? Vibhuti: Yes.

Motion: Michelle motions to extend for 10 minutes. Aminah seconds. Motion passes.

Ellenoor: This is just a suggestion I thought of, with the international fees I think it's important to have that distinction, since there are some international students who worked hard to get scholarships, would it have to be the entire tuition, what limit will we give?

Vibhuti: They would just have international fees on their Acorn, the way they pay is not our business.

Cam: I think this is an amazing idea, with the constitutional language are you thinking of understanding council policies language?

Vibhuti: I'm bringing this now just to have more time to talk about it since it is a new position on council; if this does pass it will be put into Gabby's things, and we can add the same policy to Michelle's package.

Katie: How do you see this position interacting with the International Mentors and VISA?

Vibhuti: I have it written in the policy.

Alexa: I think it's great to have this added in!

Vibhuti: Since I think our student population is diversifying, ¼ of our students last year was international and we don't have that diversity here, I think it's important we see that here.

COMMISSION REPORTS:

Academic (Lucy & Nerija): 4 minutes

Lucy: Networking dinner happened on February 3rd, it went super well, thank you all for your help! The Alumni and students all seemed to be happy, I'll have the photos soon once I have an SD-card reader. Language learning cafes are happening again, for Spanish it will be February 26th, we will have another early March for Portuguese. We are having an immigration workshop in mid-March with an immigration advisor, this will be directed towards international students, how do you get a PR, how do work visas work, how does a limit on hours you can work on campus works, how can you get an extension if you want to work more than 20 hours, etc. That workshop will be fun, and yeah I think that's it.

Commuter (Michelle & Rheannon): 5 minutes

Michelle: I have two things for you, Commuter Assassins, sign-ups have started, we have about 20-something spots left, we are restricting signup to commuter students but if we have extra gaps then we can take in res students. I will send an update closer to the start of the games on February 24th. On that Friday, the 29th, there will be a check-in at the VUSAC office at 5pm, I will send more info on that. I've been in touch with commuter reps and we've been thinking of having commuter appreciation week which will be at the start of March.

Scarlet & Gold (Tran): 3 minutes

Tran: Highball tickets were on reservation yesterday, they were all sold out! Adding onto that, ticket sales will go from March 2nd-13th. In addition to that, the affordable formal wear sale is happening, if you guys are going home for reading week and have anything you want to donate, please do, we are taking donations the week after reading week, and then the sale will happen March 2nd-6th! If you all want to sign up for a shift that would be cool as well! Highball committee will start decorating soon so please be mindful of their things in the backroom.

Sustainability (Aminah & Leila): 7 minutes [Appendix E]

Aminah: Thank you everyone, environmental equity week was successful, and I'll touch on the document. Leila and I are coming up with composting now and waste managing guidelines, essentially we emailed Green Shift, and they gave us a very thorough response, questions came up on whether products were compostable. City of Toronto is a mess with waste management, they aren't investing enough to change their policies, their guidelines are changing, she said it's good for us to stick with Green Shift because they have a minimal effect on the environment, if you read

Ellenoor: Does the email say that some places can compost in their own facility? And if so can we?

Aminah: that's something to bring up but it would brought up as a sentence, hopefully PhysPlant could take it somewhere, we also have contracts with the City of Toronto that would complicate that.

Alexa: It's April 3rd? Would we want to look into closing the VUSAC office again?

Vibhuti: We all know Cedric is sick, the other first year that Aminah brought absolutely killed it; Jerico did such a good job, that's a testament to the way Aminah is empowering her councilors.

EXECUTIVE REPORTS:

VP External (Vibhuti): 5 minutes

Alexa: Happy Valentine's day, love you all, thank you for spending it with us. I want to talk about a few things I love, starting with the Board of Regents – that happened Thursday February 6th, we have a new chancellor, it has been announced online, Nick Saul, many students and faculty involved in this process are confident, Robins also mentioned that he will be presenting a revised version on the legacy of Ryerson at the June BoR meeting, we have a date for that proposal. Another governing body, the VCC met this past Monday, started with a presentation from the Experiential Learning & Outreach Office, they highlighted some of Vic's programs. Experiential learning is out of classroom unique learning opportunities that students have to strengthen their learning like doing research, working at a library. They will have a new office on College soon. Robins also had an update where he mentioned his strategic plan, they are hoping to have the final strategic plan the first wek of April and it will be voted on that month. There are no decisions on Frye yet, they haven't decided what they will do yet, another VCC update – we are hoping to hold the college life committee sometime in March, we want to make sure we have enough students at that meeting. One of the things we want to discuss and figure out is the purpose of that at that meeting. There are also two new courses: Posters and propaganda for first year students, and special topics in science and society, they made three of their full year-long courses half year courses. The DAC also met this past Wednesday, we had lots of interesting discussions, I wanted to highlight that Burwash Study space will be bringing back fruit, and they're looking to bring back fruit regularly so I'm excited about that. We have wanted to introduce a Commuter Orientation part 2 during reading week and introducing that as another touch-point for international students, it may be an option to explore, apparently in the psat they've had trips to the Hart House farm. So that's exciting to see that might come back! We also had a discussion on mental health, Vic was doing a lot of what was recommended in the Provost's reports already, but there are many improvements to be made on how to centralize what the college can offer. We've also talked about the faculty's role in mental health and will be exploring ways to create a guide for professors on how to teach us, I think most of the Vic profs do a great job already but we are hoping to expand that. The Student Choice Initiative, I haven't heard about our opt-out rates, I think the choice is that if students opted out, they will remain so, retroactively making them pay their fees is complex, but that may be the only year with the SCI. And the VUSAC Strategic Plan, the surveys are out, please share and fill them out! I have enjoyed reading them, that being sad, having a SP for a body with 1-year terms is difficult since they are usually for bodies with the same team for a certain amount of years, so we need to sort that out.

Massoma: Is there a timeline for the strategic plan, when the in-person stuff happens and when the final document will be rolled out?

Alexa: The in-person stuff will happen the week after reading week, hopefully for a minimum of 2 weeks then will present it at the March 20th meeting or the last meeting.

Vibhuti: One, just to clarify, the Ryerson reports Robins is bringing is his own research that he is bringing, it is separate from the report sent. Two, Alexa, Spandan, Angela and I went to the UTSU meeting if you wanted to say a few lines.

Alexa: It happened Wednesday evening, a huge part of that meeting was sorting through their bilaws; they combined the VP external and university affairs to one position. The new position is called Vice-President Public and University Affairs. They also moved all their committees out of their bi-laws to their internal policies so they don't have to vote on them at every SGM. You can see all their changes on the website.

Vibhuti: UTSU elections happen on March 2nd. If you want to run for the UTSU you can start doing that soon, it is a great way to get involved in politics outside of VUSAC.

Lucy: Did VUSAC appoint Aloysius as UTSU director?

Alexa: VUSAC was not part of that; UTSU did internal hiring.

Jay: Why was the Vic director hired internally through the UTSU when they are usually elected internally at Vic?

Alexa: We weren't notified about it, by the time I did reach out they told me they had it in place, moving forward we will have a conversation to sort that out in the case that it happens again, it makes sense on their part since they are a member of the UTSU, but given that VUSAC does internal elections that does make sense. There may have been one Vic student on that panel but they were employed by the UTSU

Vibhuti: That conversation is not specifically about having VUSAC representation but having Vic representation on that hiring committee. Having internal elections for UTSU Vic Directors is a very new thing, before they were always voted for by the UTSU.

Disha: What is the difference between Angela's and Aloysius's role?

Alexa: There isn't a difference; the reason why Aloysius was hired is because Thomas stepped down.

Alexa motions to extend 10 minutes. Fatima seconds. Motion passes.

Disha: So now in March, those two position will be re-elected?

Alexa: Yes, in the nomination package coming out today we will be electing two Vic directors internally.

Disha: But last year those elections happened in the fall?

Alexa: Last year only one person ran and there were two positions we elected another in the fall.

Cam: It was the same situationa s Aminah, Aminah was new in the fall.

Vibhuti: One, the VUS meeting was cancelled, do you have any information on why/when it will be rescheduled for?

Alexa: I haven't received any emails about that, I will look into it.

Vibhuti: About the DAC, Heidi, who is a new associate Dean, she is very cool, very nice. She was talking about how Vic was part of a study from the US and Canada and they polled data about involvement and student engagement on campus, and how Vic killed it! Alexa and I are excited to see the data and see how we can incorporate that into what we do in VUSAC.
