Kristina Minella - Campus Life Coordinator

- -Feedback Thank's for your feedback from last meeting, it was really helpful

- -There's going to be a new initiative called Theatre for Thought, there's going to be partnering with VCDS and others to see how theatre promotes social justices and such. E-mail me if you're interested in this
- -Feb 15th in this room there's going to be a workshop about communication resolution. If you want more info come to me, or check online.
- -The academic skills center is going to be coming in to talk about stress management.
- -The drop in clinic went really well, all the spots were filled, just a straw poll, do you guys think if we had another one do you think it would be successful? Yes.

VCDS - Kim Pollak

- VCDS is submitting two shows in the UofT drama festival. Tickets are \$10 and available at VUSAC. They're both student written and it would be really nice if you could come support Vic, it should be a good night. Also Rocky Horror is coming up soon, everyone's working really hard on it, it's March 10, 11, 12.

VCC - Kenny Zhan

- -Enrollment at Vic is 3300 right now, we've hit the enrollment which Ontario wants.
- -There is a profile being implemented for Vic admissions, at the moment it's only being used for people near the cutoff, admin is looking for using it as more of a ranking system.
- -Due to the recession we're down for the scholarship budget. It's being mitigated by half a million dollars.
- -We've been told that none of the academic programs are on the chopping block.
- -Emmanuel college is pulling their own weight.
- Vic One, the Jewison Stream will be starting next year. They're looking to expand it to upper years. Nothing is permanent. Also, it's interesting to note that other colleges are looking to emulate Vic.
- -Renaissance studies in increasing the amount of small class courses.
- -Semiotics major is still going strong. It's up for Prof. Danesi what happens to this.
- -There have been some personnel changes in Alumni office. If you want more info come talk to me.

Akash: They're looking to start a Vic/Trin joint program. The professor is names Al Moritz. He's actually the professor for the Jewison stream. It's interesting that how they named the professorship in the new stream after a financial donor, it's called the Goldring professorship. I let them know that I was uneasy that a donor was potentially directing the syllabus. They ensured us that the programs would be coming from within the university. Also, the semiotics major is in its last years. As well, the cut off average for vic is roughly 82%. Also International students are about 10% of the student population at Vic, slightly lower than the 12-13% predicted by U of T.

Kenny - The Goldring issue: We were assured that the program was set forth and planned out before a professorship title was given. all the academics have been planned, it's just a title.

Akash for Cindy - Finance Chair

- -Finance chair applications close tonight, people on the committee will be notified this week. We got 5 applications
- -Brandon and Cindy have performed the levy audit, there's some problems which I'll talk about later. The Cat's Eye was missing some receipts. This is the first time we've done this. There were two specific cases where I received a paper receipt, and it was kind of tough to sign the levy check. VCDS overspent on their alcohol and I didn't release their levy check. We agreed they would deposit \$100 in their bank account and then we would release it
- -Ticket selling procedure. thanks for taking good care of the money box. Is everyone aware on the online sheet? It allows to make more comments for what happened during your shift, Cindy has asked that any money be deposited in the president's office.
- -Maybe it's best to consolidate everything, all the events into one log?
- -Alex: I set up Cindy's log, and she just wanted to have all the money kept separately
- -Akash: Bracelet of Hope was wondering if we could set up a permanent bracelet sales from the VUSAC office.
- -Ashley Why don't they buy their own money box?
- -Alex VicXposure does have their own money box
- -Gabrielle I think this is a good solution but it's too late in the year for it to be a part of their budget
- -Akash I think since the clubs are part of VUSAC, we can let them use a money box until it's needed
- -Dora I can check with Gill whether or not they have a money bag, we used to.

Harrison: Ok good. Any assessor members can leave now.

Judiciary Reports

President [Akash Goel]

- I met with the board of Regents yesterday. It was an interesting discussion. For all intents and purposes the board has, not unanimously, approved the extension of Professor Gooch's term. I'm not really at liberty to tell you what happened exactly, there was some unease, but it has been extended.
- The Goldring center is breaking ground on May 28th. The money has been borrowed and it's happening.
- I'm also chairing the elections and appeals committee this year. We have started the process for hiring a CRO.
- I'm also on the High Ball Committee and the decoration sub committee I think...
- We're looking for venues for Grad Banquet. I wont tell you the theme
- I've made some comments about the Alumni office because I think that they haven't had good communication with us, for example with the Vic 175 events. I wrote a report to the Board of Regents. I changed it a bit, because it was a bit antagonistic. I got some e-mails from the alumni office: Hi again akash. I've heard that the board of regents

went so well last night that President Gooch is going to sponsor 50 tickets. If that was your idea, well done. We're now selling tickets for the oscar party from them

- I got selected to be on the committee on the governing council on the use of student space. There was a huge debate over the charging of student space, based on clean up cost and security. Many of you will agree that this is kind of unfair. So there's now a discussion group for this.
- There's a lot more going on, but I don't want to go into it right now, so if you want to talk, just ask.
- <u>Motion 210:</u> Referendum: Akash moves for VUSAC to give the president and the judiciary authority to formulate and present a referendum question regarding the CPI plus 2% increase along with the associate protocol as discussed in previous meeting. Adel seconds.
 - Essentially I'm asking for the authority to come up with the question so I don't have to come back to VUSAC to discuss it.
 - Rob: In order for a referendum question to be passed it has to be ratified by VUSAC
 - Akash: We just want to formulate the question
 - Brandon: I don't see a problem with formulating the question and bringing it to VUSAC to vote on it.
 - Akash: As you know we need time to advertise it, we can do an e-mail vote if you want
 - Rob: It's a minimum seven days for advertising
 - Akash: It would be too late for the meeting.
- Motion 210 result: Vote: 9 for 8 opposed. Motion passes
- Thank you. I assure you that the judiciary will be sending regular updates. That's all for my update. I hope that was short enough for most of you.

Harrison: You were ten minutes on your time. Well done. Now on to constitutional amendments. If you find that I'm telling you that you're taking too long, don't take it personally, I'm just trying to make everything go smoothly

VP Internal [Clara Ho]

• Constitutional Amendments

- Harrison: As requested, Clara it's your floor. As you can see we've slated an hour for this. I'm anticipating that it will go over this time. So I'm going to be prepared for somebody to request an extension. But I will only allow one, so keep that in mind.
- Akash: Just a personal request that we place specific attentions to those motions/ amendments regarding the elections, the things that are coming up soon. And maybe stay open to discussing others at another meeting perhaps. The very sanctity of this document is how we govern ourselves, so just keep that in mind.
- Clara: So we'll begin by going through each amendment by approving each individually and we can discuss those as they come. The first is Amendment 4, regarding the addition of a Residence commissioner. I'll read it first and then we can solicit feedback. (*see attached document*). I think regarding discussion we can talk about the general idea about having a residence commissioner.
- Akash: I think if we're going to make changes to this, we have to go through the rest of

the constitution wherever it says the VPE in conjunction with the residence commissioner.

- Rajesh: Can we shed some light on why this is necessary?
- Brandon: Residence students are about 1/4 of vic students. There isn't a commission who just represents the residence students.
- Matteo: A question. I don't see why we're adding this to the special projects levy committee if we're removing the commuter commission and replacing it with the clubs commissioner
- Brandon: I think the residence commissioner would be removed from special projects
- Kim: Is it okay if we just don't read everything out in the interest of people who have to leave?
- Harrison: Has everyone read this? That seems okay.
- Ashley: I have a question as to why they're on the grad banquet chairperson selection committee? Since theres not many upper years in residence
- Akash: Correct me if I'm wrong, but I believe it's because the commuter commissioner is on it.
- Annie: Why would the Residence commissioner be on the highball committee if so many building presidents are on it
- Brandon: That was a typo, it's supposed to be taken out.
- Clara: I was just thinking, should there be a motion to approve the Residence Commissioner as existing in council and then approving the rest of the details?
- Harrison: So separating the position from the responsibilities.
- Brandon: I don't think they can be separated
- Clara: So let's pull out parts of the amendment and approve it, and then go back to the position
- Harrison: So if you have any concerns, bring them up now
- Akash: So have we ceased discussion on questions? Especially since we have a building president here and we can discuss it.
- Rob: What's the point of discussion very specific issues if the big issues might not be passed, it seems like a waste of time
- Harrison: Well everything we talk about is a potential waste of time
- Akash: Can we proceed with the way that Harrison wants
- Matteo: I'd like to remove section three from amendment 4. Does anyone have a problem with that.
- Harrison: Does anyone have a problem with that?
- Clara: I think we're having a miscommunication. What are we doing?
- Harrison: Everyone is going to go through pulling out each one and then voting on it as a whole later
- Julie: I think that we should get rid of section 11
- Emily: Maybe add working with the commuter commission as well
- Annie: Maybe they should add to happen with commuters
- Kim: why don't we vote on this first. otherwise we're wasting time
- Akash: The way that I've understood it in the past is that the amendment is voted on, we have discussion in between, with several mini amendments in between.
- Clara moves to approve Amendment number 4. Akash seconds.
 - Matteo moves to remove section three from the amendment. Motion passes

unanimously.

- Annie moves to remove section 6 from amendment four. Ashley seconds. Motion passes with 2 abstentions.
- Alex moves to amend subsection 11to remove how it excludes residence students.
 Seconded by Annie.
 - Akash: I suggest that we change it to include commuter students.
 - Alex: I move to change section 11 to include commuter students.
 - Kim: What does this mean 'major event'
 - Akash: It's to include flexibility for each council.
 - Gabrielle: It seems redundant to include commuter students, why can't it just be for 'students'
 - Rob: It's like they're just half a commissioner
 - Annie: If they don't have this event they're not going to be a council
 - Dora: I think Kim made a good point, you guys are going to be talking about this all night if you don't send it back to the judiciary.
 - Akash: This process has been very poor. There's certain amendments that add a commissioner and then don't have it in other part. There's some fundamental flaws with the constitution. It's sad, cause I want to do this right now. But I think everyone needs to look at the amendments that they proposed and then look through the constitution and see if everything matches. I'm going to suggest that we go through and see what's solid enough to work with today.
 - Alex: I withdraw my motion.
 - Clara: I withdraw my motion as well.
- Matteo: How are we supposed to know which ones have been searched well or not?
- Gabrielle: There are people who are well versed on the council who can tell which ones are solid or not.
- Akash: Just to know, the judiciary has withdrawn creating the social justice and equity commissioner. I'm suggesting we go over only elections amendments today, and then spend reading week going through rigorously to make sure everything is good to go and we can go over the rest on our saturday meeting.
- Clara: There are a number of amendments here that are larger amendments that are more contentious than others. How about I suggest which ones to remove and how to continue.
- Harrison: Why don't we have a five minute break and we'll decide how to continue when we come back.

Jennifer leaves at 6:48.

Break at 6:47. Meeting continues at 7:09.

- Clara: We had a quick meeting and went through all the amendments. We've kept some in that we feel that are consistent throughout the constitution. We are proposing to discuss amendments: 5, 6, 8, 11, 12, 17, 18, 19, 20, 22, 23, 24, 26, 27, 29, 30, 32.
- Kim: Why haven't you included amendment two.
- Clara: We don't have all of the parts where it's changed
- Kim: Well I went through all of that work and it's not my fault that you didn't put it

there. I'm sorry that you didn't do that but it's not my fault.

- Akash: Kim, I know we met at the beginning of the year and both agreed about the name change but I don't know if we can do this right now.
- Dora: I think the reason for having them voted on is fine... It's only a name change right? It's not any substantial change so I think you can still vote on it.
- Clara: Ok, so as long as 3/4 of people vote on it we can. Let's put 2 back on table
- Clara moves to approve Amendment 2. Rajesh seconds. Motion passes unanimously.
- Brandon: Should we discuss the other Productions amendments since it was only because of the name change that it
- Akash: Let's maybe talk about it at another meeting?
- Kim: I missed a class to have these amendments in on time it would be nice to see some of them go through, I will resubmit the ones which were not presented to the judiciary for the next meeting

Kim and Akash step out at 7:18

- Clara: 33, 34, 35 are back on the table. Ok, amendment 5. see document This amendment is in direct connection with amendment 6, so I shall discuss both but we will vote separately.
- Motion 211: Clara moves to approve Amendment 5. Brandon seconds.
 - Harrison: Discussion?
 - Rob: What happens if a referendum get's called before a CRO is in office
 - Brandon: We're in a weird place right now because the CRO resigned this year
 - Alex: If the CRO resigns again, what will be the plan? Will we immediately hire a CRO?
 - Brandon: Yes
 - Adel: Does the CRO get fully paid if they resign?
 - Brandon: No.
- Motion 211 result: Motion passes unanimously.
- <u>Motion 212:</u> Clara moves to approve Amendment 6. Gabrielle seconds. 14 in favour. 2. abstentions. Motion passes.

Akash and Kim come back at 7:23

- Motion 213: Clara moves to approve amendment 8. Seconded by Gabrielle
 - *Motion 214:* Gabrielle: I move to change by law 41 ssb, the 10 hours to 4, because it gives them one hour a week. Seconded by Rob.
 - Akash: I think that, talking to some of my predecessors, I feel like sometime space allocation sometimes seems like it gives preference to UofT groups instead of vic groups, and we might want to give more to vic to induce more collaboration with students and bring groups together.
 - Alex: I really support Gabby's motion because I think that most vic clubs only use 4 hours a week, and we need to give priority to vic student
 - Rob: I tend to agree with Akash about collaboration being important, but I
 believe that external clubs collaboration with our clubs, as has been done in the
 past, is a better way to do it than direct collaboration with VUSAC.
 - Gabrielle: I think Vic Groups are given priority because they must book through either the VPE or the Clubs commissioner, not go directly to the Internal Events Co-ordinator.
 - Ashley: A point that has been brought up to me is that we only recently got free

use of space and seeing as how technically Conference Services has jurisdiction over that, do we have to consult with them first?

- Akash: It's a privilege clubs have had for a long time
- Dora: I worry about outside groups having bookings through you. For example, last year the UofT Got Talent was at Bader and supposed to have a VUSAC rep, and it didn't and the conference leaders weren't very happy with it
- Akash: Maybe then the best thing to do would be to have a VUSAC member at all events like that. Theres a strict process regarding space allocation.
- Kim: I think there's barely enough space for Vic clubs as it is right now, I think we should wait until the Goldring center opens.
- Gabrielle: there's actually a lot more than people think.
- Motion 214 result: Motion passes. 2 opposed.
- Akash: Do we not have to include in the VPE and Clubs section that they need to be a part of booking space. I'd move to table this and talk about it another time
- Gabrielle: I'd like to draw your attention to By Law 1, and suggest that we just remove the VPE from this.
- Akash: So we're going to strike the clubs commissioner?
- Gabrielle: No, we would strike the VPE.
- Akash: Currently it seems like this is a clubs commissioner thing, but I feel like this should be a VPE thing
- <u>Motion 215:</u> Gabrielle moves to amend bylaw 41 section 1 subsection b to 'associates clubs can book space through the clubs information. Tied.
 - Harrison: Just give me a minute to read this through. Point of information: Who currently deals with clubs bookings right now?
 - Akash: They go through Cindy. I think the reason that we are at a deadlock is because people are not sure whether or not this should be a Clubs thing or a VPE thing.
 - Harrison: Can is see the constitution?
 - Harrison: Okay, I've decided. Given the fact that the booking of student space would apply to clubs primarily, and this seems to deal with the clubs commissioner, I'm going to vote for the motion.
- Motion 215 result: Motion passes.
- <u>Motion 216:</u> Akash: I move to amend by law 41 section1 ssb to VPE can book space for associates for a max of 4 hours. Rob seconds. 7 for. 9 against. Motion denied.
- *Motion 217*: Emily: I move to remove the typo from section 7. Gabrielle seconds. 12 for. 2 opposed. Motion passes.
- <u>Motion 213 result:</u> Harrison. All in favour of passing amendment 8? 9 in favour. 4 opposed. Motion passes.
- Akash: I just want to say for Gabrielle and Brandon who worked so hard for getting this through, congratulations for getting it through.

• Motion 218: Clara: Amendment 8a. It's roughly in connection with 8. It's the creation

of a new bylaw. I move to approve amendment 8a. Seconded by Alex. Motion passes unanimously.

 - Alex: Question: What does it mean by researcher? Does it mean like in conducting surveys?
 - Akash: CIA.
 - Alex: Okay.
 - Gabrielle: Does it talk about levy receivers?
 - Brandon: Yes, it's called constituent organizations.
- Motion 219 result: Motion passes unanimously.
- Motion 220: Clara moves to approve amendment 12. Brandon seconds.
 - Brandon: I move to change levy receivers to constituent organizations. Rajesh seconds. Motion passes unanimously.
 - Rob: Should we change the meeting numbers to more than once per term
 - Brandon: The reasoning is that the VPE meets with the levy receivers individually throughout the year, but only as a group twice.
 - Rob: ok.
- Motion 220 result: Motion passes unanimously
- Motion 221: Clara moves to approve amendment 17. Rajesh seconds.
 - Akash: Just wondering what does ancestry do in there?
 - Alex: It's just another thing that people could be oppressed for.
 - Akash: Interesting
 - Dora: Is ability supposed to be bolded?
 - Akash: yes.
 - Rob: Why did you remove international student part?
 - Brandon: The entries in the constitution for E&E committee and commission are different. This is just an attempt to line the two up
- Motion 221 result: Motion passes unanimously.

- <u>Motion 222:</u>Clara: moves to approve amendment 18. Rob seconds. Motion passes unanimously.
- <u>Motion 223:</u>Clara moves to approve amendment 19. Emily seconds. Motion passes unanimously.
- <u>Motion 224:</u>Clara moves to approve amendment 20. Carrie seconds. Motion passes unanimously.
- Motion 225: Clara moves to approve amendment 22. Gabrielle seconds.
 - Alex: I'm wondering why it says many instead of all.
 - Emily: It says 'the many'
 - Alex: Oh, sorry I misread.
- Motion 225 resultMotion passes unanimously.
- Motion 226: Clara moves to approve amendment 23. Emily seconds.
 - Alex: Why has the interview process been removed? I find that this is the best way to choose a committee.
 - Emily: It takes a lot of time, and I think it should be up to the commissioner.
 - Julie: We saw this in the conference applications, some people put no effort into it and didn't even deserve an interview.

- Kim: The amendment doesn't take away the possibility of an interview.
- Rajesh: Don't you want to see what they look like?

 - Emily: I don't know if you want to add the complete executive committee.
- Motion 227 result: Motion passes unanimously.
- Motion 228: Clara moves to approve amendment 26. Emily seconds.
 - <u>Motion 229:</u>Akash moves to change all the 'Sid Smiths' to Sidney Smith. Brandon seconds. Motion passes.
- Motion 228 result: Motion passes unanimously.
- Motion 230: Clara moves to approve amendment 27. Seconded by Rob.
 - Rob: It's the same as E&E, just adding general members.
- Motion 230 results: Motion passes unanimously
- <u>Motion 231:</u> Clara moves to approve amendment 29. Gabrielle seconds. Motion passes unanimously.

Kristina leaves at 8:05

- Clara move to approve amendment 30. Gabrielle seconds.
 - Rob: My entire role is to advocate for commuter students, and the application for special projects may allude to commuters and so I don't see the need to remove me from this committee.
 - Akash: First Rob, don't forget to distinguish between you and the commuter commissioner. I agree with half and I don't I don't think that the Clubs commissioner should be a voting member, but I don't think a commuter commissioner should either. So I don't know how to proceed.
 - Shoaib: I kind of disagree with Akash. The commuter commissioner needs to be there to advocate for commuters, I've been to a few meetings and the commuters need to have representations.
 - Ashley: There's a reason to have the commuter commissioner there is to keep representation for the commuters.
 - Gabrielle: I move to keep in the commuter commissioner and just add the clubs commissioner. Brandon seconds.
 - Matteo: I'd just like to say that since the majority of Vic Students are commuters, we should keep the Commuter Commissioner on the committee as this position represents the majority of the student body by default, due to the nature of the role

AMENDMENT 1

ADDITION OF A COMMISSIONER:

Sx) The Social Justice and Equity Commissioner, who:

Shall appoint a student to chair the Education and Equity Committee as per By-Law #37 Shall appoint a student to chair the Sustainability Committee as per By-Law #38 Shall represent Victoria College students concerns regarding, but not limited to, age, ethnicity, gender, sexual orientation, economic background, ability, citizenship, nationality, ancestry, and personal, political, or religious beliefs. This includes listening, responding to, and interacting with the voices of the Victoria College community. Shall represent Victoria College student concerns regarding, but not limited to climate change and initiatives, behavioural modifications, energy consumption, sustainable water and food practices, community gardens, and building codes. This includes listening, responding to, and interacting with the voices of the Victoria College community. Shall advise the Victory University community of inclusiveness and equitable representation. This includes recommendations of improvements related to equity and accessibility to facilities, programs, and services at Victoria University. Shall be co-Chairperson of the Victoria Working Group on Sustainability with the Director of Physical Plant Services.

- ssa) Shall conduct an annual review of Victoria University's sustainability policy
- ssb) Shall promote new sustainability initiatives at Victoria University
- ssc) Shall review Victoria University's progress with regard to sustainability Shall be responsible for coordinating with the International Student Life Coordinator to represent International students.

Shall be responsible for providing the Victoria College community with educational programs, services, and events.

Shall represent Vic at the Environmental Working Group hosted by UTERN.

Shall be responsible for the annual review of VUSAC's sustainability policy.

Shall collaborate with other student clubs and organizations on campus.

Shall be responsible for administering the VUSAC travel and conference fund through an application process that will open once per semester.

Shall be responsible for working with the VUSAC President and the Campus Life Coordinator to organize and facilitate equity training for the entire council and the Education and Equity Committee. Equity training must occur before the end of October. Shall be responsible for the preparation and presentation of a detailed year-end report, containing information vital to the interests of the incoming council members, at the joint meeting of the old and new councils.

Shall be responsible for the planning, maintenance, and upkeep of the Goldring Student Centre's green roof

Shall collaborate with other student clubs on- and off-campus to promote environmental stewardship and sustainability

Reason: To streamline the council. Will replace the Education & Equity and Sustainability Commissioner's roles and responsibilities. However, two co-chairs will be appointed to head the E&E committee and Sustainability Committee.

BY-LAW #41: ASSOCIATE RECOGNITION AND OPERATING POLICIES

- Associate recognition by the VUSAC is required for all VUSAC associates in order take advantage of certain privileges, such as access to room bookings on the Vic campus, opportunity to apply to the VUSAC for funding, and inclusion in student handbooks and/or websites produced by VUSAC or other Victoria Offices.
 - ssa) Associates will have the opportunity to apply for funding from VUSAC, funding remains at the sole discretion of VUSAC and is not guaranteed. When possible, Associates should obtain funding from outside of VUSAC. VUSAC-recognized clubs will always be given preference in funding and associate clubs will not receive funds that VUSAC believes should otherwise be allocated to VUSAC-recognized clubs.
 - ssb) Associates can book space at Vic through the VP External and Clubs Commissioner. They can book a maximum of 10 hours per

month.

- S2) Recognition must be renewed annually. Recognition granted at any point in the year will expire on the following September 30th.
 - ssa) Recognition may be retracted at the discretion of VUSAC, upon recommendation from the Associate Status Committee.
- S3) The associate status committee shall consist of:

the VUSAC President who shall act as a voting chair

the Vice-President External

the Clubs Commissioner

a

- a Member-At-Large, as appointed by the Judiciary.
 - ssa) Any motions presented at the Associate Status Committee must receive 50%+1 majority in order to be considered carried.
- S4) To be recognized by the VUSAC, an associate club must meet the following minimum requirements. The associate club shall:
 - ssa) Actively and effectively recruit members from within the Victoria community.
 - ssb) Submit a fully completed associate status form to the VUSAC office.
 - ssc) Submit an updated constitution.
- ssd) Have one member of the executive who is a member of the VCU and functions as a representative of Victoria College.
 - sse) Have a membership that consists of at least 75 VCU members, with no restrictions placed on percentage of membership. In rare cases, the Associate Status Committee and the VUSAC may disregard this requirement if it is not practical for the application in question, especially if the applicant maintains a historic connection to Victoria University.
 - ssf) Send a representative to the VUSAC Clubs Brunch during Orientation Week.
 - ssg) Send associate club head, or representative, to the mandatory clubs meetings occurring once each term. Meetings are to be scheduled by the Clubs Commissioner a minimum of two weeks in advance.
 - ssh) Send an associate club head, or representative, to give an update to the Vic Caucus at the mandatory caucus meetings.
- ssi) Submit a written report at the end of each term detailing the following: finance, description of events (including participation), upcoming plans, suggestions pertaining to the structure and function of the associate, and a summary of its relationship with the VUSAC.
- ssj) Associate club heads must submit a 100-150 word report by the third Friday of May, detailing their association's function and the contact information of the incoming associate executive for use in the Victoria University Handbook.

S5) Membership:

Membership in the associate club may not be denied to any member of the VCU except for the following circumstances:

- ssa) The nature of the club requires special talents or abilities which are not held the applicant (e.g. musical talent).
 - ssb) The applicant has demonstrated disruptive tendencies which would seriously

undermine other students' enjoyment of the club. In such a case the applicant should be informed in writing of the clubs' reasons for rejecting the application. All such rejections may be appealed to the VUSAC and the rejected applicant must be informed in writing that (s)he has the right to make such an appeal.

S6) Advertising:

An associate club must actively encourage participation and attendance at its events. At a minimum, the associate club must:

ssa) Submit a schedule of events (including meetings) to the VUSAC Clubs Commissioner and for inclusion in various communications vehicles, i.e. Website, Strand ads, Student List-serv, etc.

ssb) Place posters around the campus announcing the first few meetings (with date, time and location) for the club in the Fall so new members can get involved.

S7) Miscellaneous:

- ssa) All associates shall abide by the Victoria University and the University of Toronto codes of student conduct and shall be held accountable by the VUSAC.
 - ssb) Failure to comply with the aforementioned guidelines may result in suspension of privileges and / or loss of recognition, at the discretion of the VUSAC.
- ssc) A copy of this By-Law shall be included with the associate recognition form pick up by associations at the VUSAC office or on-line beginning in mid-August.
 - ssd) All applications shall be received by the Vice-President External.
 - sse) The Associate Status Committee shall decide on any applications prior to forwarding them to the VUSAC.
- ssf) The VUSAC shall consider Associate Status to be a rare privilege afforded to few organizations.
 - ssg) The VUSAC shall discourage associate clubs from maintaining similar relationships with other college councils and associations, lest the associate status be exploited for space-booking or financial privileges.

- ssd) The Judiciary and Campus Life Commissioner shall work together to summarize the information, including the chairperson's.
- sse) The VPI shall report on the overall performance of the VUSAC and suggest options for improvement and growth, in a VUSAC meeting.
- ssf) The President shall meet with all commissions and provide constructive feedback.
- ssg) The internal review process is to occur at least twice a year, and at least once per semester.

S3) Student Participation:

- ssa) Any student who wishes to provide feedback may do so via email or written statement to be submitted to the Vice-President Internal with his or her knowledge before an IRC meeting.
- ssb) It is also recommended that these meeting dates be published and publicized beforehand.
