<u>Motion 267:</u>Kim moves that \$105 be moved from the VUSAC contingency to the Arts and Culture production line 009 regarding the ballet trip. Seconded by Adel. 15 in favour. 2 opposed.

## Orientation Executive Selection - Clara Ho

<u>Motion 268:</u> Clara moves to ratify Shoaib Alli, Jennifer Banh, Hope Caldi, Katelyn Johns, Christianne Johnson, Rebecca Martin, Carrie Proctor, Ruta Rudminaite, Dave Stewart, Andrea Titus, Anastasia Tsagrinos and Zenia Turkewych-Miner as the new

orientation executive of 2011. Seconded by Alex.

Sarah - I know that there were some instances when some people have been chosen for other positions, how will that be taken into account?

Evan - We've taken that into consideration when choosing.

Rob - We have several of the committee members here - Davin, Kristina, Evan, Akash,

Clara - can any of you speak as to whether or not you felt the selection process conformed to the constitution?

Rachel - As a non voting member, it was clear that everything was done properly, especially with my position as a non voting member, and Clara's position as a non voting member.

Evan - It all went through unanimously.

Akash - Only one wasn't.

Rob - Well, it's made explicitly clear in the constitution that the selection has to be consensus based.

Rachel - I saw that the first time through it wasn't unanimous, but by the end I think that there was consensus by the end of the meeting.

Julie - What about the fact that there are way more girl than guys? Not that girls don't do a good job, but last year it was much more balanced.

Akash - We only had 4 male applicants, and we picked two, so that's 50% of them.

Kristina - We want to make sure that we're picking people based on how right we think they are for the job, not based on their gender.

Akash - I think in the future we need to make the role of the past committee members clear. I think VUSAC should ensure that all the people on the committee feel comfortable talking. I would like to reiterate though that I feel that the best team was chosen. Harrison - So let's vote.

Motion 268 result: 10 in favour. 5 abstentions. Motion passes.

## Finance Chair Update - [Akash for Cindy]

Akash - We just had a finance chair selection committee meeting. We're at a deadlock so we'll be meeting soon to decide. What I've suggested is hiring the chair in December, and training them for the four months before April. What are your thoughts about that? Rob - I think this is a really good idea, we actually did something similar to this in my highschool, where you had to be Finance chair for two years.

Akash - Pharmacy of Phys Ed or something has a president elect, a president and a past president.

Rachel - I think it's a junior and a senior for each position

Naafia - So what if they decide that they don't like it?

Akash - Well we'd just open up the applications again

Alex - I still don't really understand how it will work

Akash - They would be hired in December and shadow the current Finance Chair so that they could understand the work that had to be done, then they would pick up in April when the finance chair's term ends.

Straw Poll: everyone seems to be in favour

Akash - Now for Cindy's part. Some of the clubs brought up concerns that they were unaware and spent money that we cut. Gabrielle and I were wondering if we can see if there is money left in the contingency at the end of the year, and reimburse them then.

What do you think about this? What she is saying is that we would examine this at the end of the year and see how it is.

Naafia - Why were there budget cuts after the budget was given?

Akash - They were first semester events that we only cut

Naafia - Were they notified?

Akash - As far as I know, yes.

Brandon - Do you think that the problem is with VUSAC or with the club heads?

Akash - This is hard for me to answer, I think there's a problem between VUSAC and the clubs in communication

Rob - I don't think we can vote on this is we don't know the amount

Alex - I agree

Adel - I remember the meeting where Gabrielle said that she notified all the clubs.

Brandon - Is it them spending money before they got cut and not giving in the check records, or is it them spending after it was cut.

Akash - There was many e-mails and notices that there were many deadlines. And just another note from Cindy, start submitting those now!

## Campus Life Coordinator - Kristina Minella

Kristina - Some people have been asking about the TV outside the dean's office - It's not a dean's office thing, it's a Bursar thing. It's going to be divided into four quadrants, with one for ads which are going to pay for it, and the others with other things.

Akash - Two things - I heard that this came out of the Goldring budget, and second, were students notified about their money being spent preemptively?

Kristina - All I know is that it's a bursar's initiative.

Naafia - Can I made a recommendation? I'm here almost every afternoon, and it's almost always off. Why don't we use it?

Kristina - It's actually just been mounted, so they haven't figured everything out yet.

Akash - If students could have a chance to get on those TVs that would be cool.

Kristina - Just a reminder that I know it's getting to a stressful time, so if you need someone to talk to just come to talk to me any time! Also, dons will be chosen by Monday, both commuter and residence dons. Just a quick straw poll, how do you feel about having a transition workshop, and a reflection workshop to help translate your skills to next year, or interview. Ok thanks. Does anyone have any questions?

## Judiciary Reports

## President [Akash Goel]

• Things that have come up Zinzi deSilva, before she left signed a number of contracts that no one knows about! I'm going to pass around this contract. I've asked that last years VUSAC composites be mounted (this is going to be for free). I don't know if you've ever been to Kelley Library, but they have class composites made out and placed in the library. So I've asked them to do some prints and composites for classes and hopefully we can mount them and have them put up in Goldring. He's come to me

with the renewal contracts. Here are some of the things. Handling all proofs, arranging advertising, online rebates for the sitting fee (Which right now the rebate goes to VUSAC, which I think is kinda weird. I just might ask him to reduce that fee from \$25 to \$15)

- Naafia When Zinzi negotiated that contract they used that to fund Vic Overnight, which was the commuter stay over space
- Akash So would you be interested in just reducing the cost if they agree, or taking that money and contributing it to graduation in some way?
- Brandon I'm sure the provision is in there because they wont cut it straight out. I think that it would be really great to subsidize something for the grad banquet, maybe tickets.
- Akash How can we make sure that this money goes to the grad banquet
- Also, this is what the contract says: To offer VUSAC free sittings, free composites, all graduating VUSAC members a complimentary package, a bobble head doll, to provide pictures on DVD recording etc.
- There's actually a lot of things that they can offer us but that we don't take up on, like photographers for events
- Alex- As a photographer I just want to say this is a really good deal
- Akash What about having a bobble head for Crescam people as well?
- Alex I think that it's a really good idea to have for Crescam people.
- Akash So should we give to graduating Crescams and graduating VUSAC members?
- Ashley Why do graduating students on VUSAC need a bobblehead?
- Akash I guess it's kind of a conflict of interest, but I really want a bobble head!
- Brandon I think we're not going to be able to get the Crescams and VUSAC, so I think Crescam is better.
- Akash So why don't I add graduating Crescam winners and graduating VUSAC winners
- Alex I want you to take a minute to consider that the amount of labour that is going into this. I think we should think about that, UofT changed all their clothing so that it wouldn't be in sweatshops, I think we should be conscious of this.
- Akash They're made in China
- Akash So I'm going to change it to every graduating VUSAC winners and every Crescam winners.
- <u>Motion 269:</u> Akash moves to receive to sign the contract with Lassman Studios from 2012 and 2015. Also that I be given the authority to negotiate any other deals that I can for Victoria College students. Seconded by Carrie. One opposed. Motion passes.
- <u>Motion 270:</u> Akash moves to extend discussion by 20 minutes. Carried seconds. All in favour, motion passes.
- Akash One thing that's been really important is the commuter experience package. I haven't been presented any concrete details with what is going to be in it. I think that this entire project is focused on economies of scale. I'm really uncomfortable with this package. We'd like to try and delay it and talk about it further next year. We're

going to filibuster it, I learned that word from Brandon. Every time we ask them to split the project, and the answer has always been no. The only reason it seems to me is that then they wouldn't be able to dip into the other pools for different things if they separated it. Right now our greatest ally on the committee is Principal Cook. I'm going to take him out to coffee this week, and try to give friendly pressure. We do know that if all the administrators go for the yes vote, and all the students go for the no vote the chair will be the deciding vote, and he's another one we'll be taking out for coffee.

- Kristina Just so you know, Kelley has told me that if all the students vote no, then she will be voting no.
- Akash Well we don't know how people are going to vote in the end, that why I haven't said how I think my fellow members are going to act. Do you have any more feedback?
- Rob I'm still getting e-mails about it, and I've been hearing several things around campus, such as at the Political Science association.
- Alex A lot of people are wondering where the money from the fund is going
- Kristina Just a clarification, that money goes to the Wymilwood house fund.
- Alex I think students are just concerned where their money is going, and they just want a document that details it.
- Ashley Doesn't Clara sit on the Wymilwood house committee?
- Brandon Every time I've talked to people outside the bubble about the elections, the only thing they are concerned about is the Commuter Experience Package.
- Naafia There was a lot of moving going on downstairs, does anyone know where that money came from?
- Akash I'm not too sure. I don't think the concern is with people spending the money inappropriately, I think they just want to know, would you agree Kristina?
- Kristina No, I agree that it's very important, but I just want to make sure that your arguments are sound when you're presenting this. Regarding the Wymilwood house, the money doesn't all go to Wymilwood, I'm not sure why they haven't met, I think they should.
- Akash I think just that they're already adding money to upkeep, so that's why it's weird. We want to add a survey in for the elections next week to see how students feel about it, so that we can say that we've explored all possible options for student feedback.
- Naafia I think we've agreed that we shouldn't add this to the elections, that it's already too much, but we may add it to the polling stations.
- Akash I see the merit of having it as a separate document that sticks around for a few days longer. The students of the board are actually meeting later, so if you have any input, let me know.
- Naafia I think it's very valuable what Dora said, I think she was uncomfortable because we are very unclear with what's going on so far, and it would have to be a series of questions, which might distract from the elections.
- Akash I met president Gooch about Traditionals, and he said that the decision to

move Traditionals away from mens and women's traditionals is a decision that has to be made not only with one group, but with all the groups at Vic. He said essentially that if anyone tried to change it without multiple group consultation, he wouldn't allow it.

- Naafia What do Kristina and Evan think about the non-binding referendum?
- Kristina I think that it was good, and that I agree with President Gooch, I think we need to have a lot of dialogue before making a decision.
- Rob I was going to say, I was under the impression that it was a decision that was already made
- Kristina No, there is still discussion that has to happen.
- Akash I think it's important for us to realize that no certain group has the authority to take the decision in one direction.
- Ashley If no one body is in charge, then how will the decision be made?
- Akash As I understand this, it will be made from the president's office, from the top.
- Shoaib I just don't understand, and this is going to sound bad, but about the alumni, who cares?
- Kristina They give money.
- Brandon I heard a lot of sarcastic 'awws' when she said that, but keep in mind that without alumni we wouldn't be meeting in this room, so we should appreciate them.
- Akash New leader day is happening on April 8th. It's going to be a little different this year. It's 2-8 pm. There's going to be a joint collaboration with Vic Records.
- I've been working on VicOne with Principal Cook and President Gooch. And we have 80 fellows at Vic (professors who are associated with the college) some examples are Andrew Baines, Roy Baker, Professor Danesi etc. I think that there's a kind of disconnect, so we're thinking that every first year would be assigned to a fellow and be able to work on some research with them. What do you guys think about that?
- Alex I just have one concern, before I say that it sounds really awesome, it's a first year ROP, that's part of a credit, and those are really valuable for first year students in Vic One
- Adel As a first year Vic One student, I think it might be pretty hard to be thrown into the first like that. Could it be possible on second year and third year?
- Akash It wouldn't be a credit, and we're not exactly sure of the format right now, but I think it's really useful to make these sort of connections in first year.
- Kim Can the fellows be forwarded to the future Arts and Culture commissioner, so they can be added to the invite list for the Gardiner Gala?
- Ashley I know that there's lots of focus on first years, because of Vic One. So how are they working to bring in upper years?
- Akash They're looking into VicTwo for next year, it's really, really basic. I can't really comment, cause I'm not really involved, I don't have any interest in it really. I have a feeling that VCC is going into a really interesting direction, with academics. I hope that you all can keep up with it and see how it plays out.
- BG expansion What they're doing is doubling up the rooms, so that each can have an upper year mentor

- Sienna I live in BG this year, and as much as I love it, I think this expansion is a really bad idea. We always talk about bubbles, there's a definite BG bubble, most of my friends are either from BG or Vic One. I think doing this would only separate Vic One students further from the rest of Vic, and also from those Vic One students that don't live in the Vic One houses.
- Ashley I agree with Sienna, it's really insular
- Brandon Lots of dons disagree with this, they wont say it out loud, but it's true.
- Emily Lower Burwash is also a really quiet, calm option for upper year students. It would be a shame to take away this opportunity and have a bunch of first years take over. It would also be very difficult for the don to manage, and I feel like parties would be a huge issue.
- Alex There's a lot of drama with BG also, on the inside.
- Adel How many people would this be? When you think about it, it's like a small high school in a small village.
- Akash This is really out of my control. I'll try to make your voices heard. I don't know that everyone thought that it was going to be a big deal for everyone. I don't really know who's domain it is right now.
- Kristina It's Asha, Tanya and Ray.
- Akash On that note, there's four residences with Vic. There could be a commuter don
- Harrison In the Burwash constitution you can do this I think.
- Kristina I was at UC and they had this, and I have to say I really enjoyed it and benefited from it.
- Ashley Would student have keys to the building?
- Akash Maybe part of the commuter experience package would go to house fees, so that they can have access to the house. I think it would be more likely to connect the commuters to the residence students this way.
- Kristina I think it is important to pair that up. Also, how UC is at Vic, your orientation group is your house group. We don't do that here because of how Annesly is only girls, and because there's a lot of stress put on your orientation groups being different.
- Brandon The group stuff in orientation always fails, so I think this is flexible
- Emily I think that this is also due to frosh leaders, and the lack of training in terms of keeping the groups together. Most of the time students want to stay with people they have met in the residence. There has never been very much insistence on frosh groups
- Kristina I think the group thing changes all the time
- Akash I just want to say that before I recess, this is the last time we're all going to see each other in a meeting together alone, so it's been a pleasure.
- Harrison let's take a 12 minute break, and meet back at 7:15.

#### **VP Internal - Clara Ho**

- Just as a note, I'm pulling out amendment 18 because it's pretty much the same as amendment one. I would suggest that I'll move to approve each amendment, someone would second and then people could move to amend the amendment. (See appendix for all proposed amendments)
- Motion 271:Clara moves to approve Amendment 1. Akash seconds.
  - Clara: It involved adding the clubs commissioner to the special projects committee, and adding them officially as a duty to be part of the Wymilwood committee.
- Motion 271 result: All in favour, motion passes.
- *Motion 272:* Clara moves to approve Amendment 2. Kim seconds.
  - Kim: Just a question, have we talked to the dean about this?
  - Brandon: I was on the dean's endowment fund, they have a student
  - Alex I think this would be a really good idea, having applied to the dean's endowment fund, I felt like there wasn't really student representation.
  - Ashley Does Arts and Culture apply for funding? Because that would be a conflict of interest.
  - Emily I know usually the Vic Variety show applies to the dean's endowment fund, so that would be an automatic conflict of interest
  - Clara They would already be replaced
  - Kim I don't think it's a conflict of interest, if the event qualifies for funding it should be funded regardless.
  - All in favour, motion passes
- Akash I move that Shoaib comes to sit next to me.
- *Motion 273*:Clara moves to approve Bylaw 42 Seconded by Shoaib.
  - *Motion 274:*Brandon move to change sse to add 'within reason' at the end. Seconded by Rob. All in favour. Motion passes.
  - <u>Motion 275:</u>Brandon moves to strike ssh. Seconded by Rob. I think that at budget meetings people have to be able to talk frankly without worrying about if what they say is being written down or not.
    - Akash I think the judiciary voted for this not go to through
    - Brandon This was a miscommunication with on the judiciary's end. It should not have found its way here, but now that it's here I'd like to remove it.
    - Alex I know that it would be really helpful to a lot of club heads to see why they were or were not allocated funds.
    - Akash Like Brandon said, there are reasons why the minutes aren't released.
       There are ways for clubs to find out what happened.
    - Sarah Like Brandon said, it's going to be in the minutes anyways
    - Brandon It would be like minutes being taken in the Orientation hiring committee, it's just not the right atmosphere.
  - Motion 275 result: 14 in favour, 1 opposed. Motion passes.
  - Ashley What if the secretary is sick, or can't make the meeting. Who takes minutes?

- Akash I think it's fair to say that the current VUSAC could deal with that.
- <u>Motion 276:</u> Emily moves to remove the part suggesting 'biweekly meetings' out of the ssa.
- Adel Isn't this because it's per meeting? Because Sienna got paid less because she missed the first meeting
- Brandon I think Sienna is an exception because it's the first time.
- *Motion 276:*Results: All in favour, none opposed.
- Ashley Maybe I didn't read it correctly, but I didn't see a constitutional amendment taking the duty of minutes out from the Communications Commissioner, so there'd be a duplicate responsibility in the constitution.
- Akash- I think maybe we're being too strict on our own rules?
- Ashley I agree
- Rob Well we can't just change the constitution here.
- Ashley Is there a constitutional hiring committee for the secretary?
- Rob We cant really deal with this right now anyways
- *Motion 273 result:* All in favour, motion passes unanimously.
- Motion 277: Clara moves to approve Amendment 4. Seconded by Adel.
  - Rob I think the old system is better, I don't think we should change it.
  - Alex I feel that the new method is a lot less judgmental, and is a little more fair and kinder to the people
  - Rob Should it be though? I don't think internal review should be something that is soft and cushy?
  - Alex Well should we be hurting members of our team?
  - Kim- Well because all the anonymous feedback is synthesized and lost along the way. I feel I could do a lot more with my internal review if it's constructive.
  - Emily I don't think there was a problem with the process, but I think the way we could have received it could have been better, maybe as a sheet of paper or something
  - Julie I felt like it was very general, by putting it by commission. I think it should be by individual instead.
  - Brandon A lot of the concerns that I'm hearing is that people want to hear what people said about them. I move to add ssh which would say that each member gets to receive the raw feedback data.
  - Ashley When I was on VUSAC last year, the feedback that I received was fairly general and soft. It's more democratic to have direct feedback from everybody, and if you have a separate committee giving the feedback, they might not see what other members of VUSAC see.
  - Akash I've been unfortunate enough to have both experiences. The first was horrible, I don't think it should ever be that way. The way it happened this year was good. If people know that their comments are going to be directed to people, they may act differently in their comments.
  - Kristina I echo those sentiments, and I would make the recommendation that the VPI uses student voice to compile that information, that would be an easy way to

- give out that raw data.
- Alex I think that the new method, with the personal data, would be a lot less aggressive.
- Ashley I know that we had some problems with communicating with each other this year, so receiving direct anonymous critiques from each other may be better than sanitizing the truth.
- *Motion 277 result:* 14 in favour. 1 opposed. Motion passes.
- *Motion 278:* Emily moves to change campus life commissioner to campus life coordinator. Seconded by Akash. All in favour. Motion passes unanimously.

#### Adel leaves at 7:53

- Emily I don't know if it's worth adding individual commission members to specify.
- Alex I don't think this is necessary, commissions would be judged by their work so singling out individuals is unnecessary.
- Akash I think having it general to commission keeps the internal review constructive.
- <u>Motion 279:</u> Clara moves to approve amendment 5. Seconded by Jennifer. Motion passes unanimously.
- Clara withdraws amendment 6.
- Motion 280:Clara moves to approve amendment 7. Seconded by Alex.
  - Rob I don't know how feasible this is, but maybe we should not make this specific to buildings, since we don't really know in the coming years what they're going to do with student space. I don't know how we would change that though.
  - Clara Change it to buildings that have student offices?
  - Brandon We should keep in mind that that would have Caffiends added to this.
- Motion 280 result: Result: All in favour, motion passes.
- <u>Motion 281:</u>Clara moves to approve amendment 8. Seconded by Alex Gabrielle arrives 7:59
  - Emily Did you remove this from VPI, President and the Commuter commissioner as well?
  - Rob Isn't there a committee already?
  - Alex Are you asking if anyone else has been removed?
  - Emily Clara, are you going to take care of that?
  - Clara Yes.
- Motion 281 result: Results 14 in favour. 1 abstention. Motion passes.
- Motion 282: Clara moves to approve Amendment 9. Seconded by Emily.
  - Alex I'm not sure that weeks as events are very effective. I feel like instead of mandating weeks, we should be mandating specific events per semester
  - Ashley For sustainability we don't have specific mandates for environment week, it's just very open so that each commissioner can interpret it as they will; it doesn't have to be a full week of events, for example, and they can do whatever events they think would be best.
  - Clara Maybe we should remove that part, and have it in as a possibility, but it

- shouldn't be constitutionally mandatory.
